CALL TO ORDER

The meeting was called to order by Chair Katrina Lunsford at 1:30 p.m. followed by introductions of all those present.

APPROVAL OF MINUTES

NEW BUSINESS

Recommendation: Approve an Increase In-School Youth (ISY) Incentive Plan from \$480 to \$950

Chair Lunsford called for a motion to approve the Increase for the In- School Youth Incentive Plan. Barbara Mincy explained the changes to the in-school incentive plan. She explained that participants can receive a \$150 completion bonus when they complete an education program. The motion was made by Amanda Wilson. Ginger Garner seconded. Chair Lunsford opened the floor for discussion. There was no discussion. All voted. Motion carried unanimously.

Recommendation: Approve to create a mental health partnership to serve at risk youth

Chair Lunsford called for a motion to approve the creation of a mental health partnership to serve at risk youth. Amanda Wilson made the motion, seconded by Yesse Olivas. Lunsford opened the floor for discussion. Mincy explained that Guidance and Counseling is one of the fourteen elements of the WIOA youth program, comprehensive guidance and counseling gives youth an opportunity to discuss bullying, or anything they feel is necessary. There were questions regarding selection of a mental health provider, age demographics and engaging colleges students. Mincy shared criteria for youth to participate. There was no further discussion. All voted. Motion carried unanimously.
